## **Ongoing Consultations:**

1. Government Consultation: Parish poll consultation closes 30th January 2015 The Government has opened an eight week consultation on the modernisation of the parish poll process. A copy of the proposed changes and questions asked in the consultation can be found

2. LCC: Onshore Oil and Gas Supplementary Planning Document

The three authorities are producing supplementary planning guidance for onshore oil and gas developments, to provide guidance on the implementation of adopted development plan policy as it would apply to onshore oil and gas exploration, production and distribution.

A scoping consultation was carried out between 27 June and 25 July. Comments received during this consultation have informed the preparation of a draft supplementary planning document.

The draft Supplementary Planning Document is published for comments, together with a Scoping Consultation Outcomes Report, and a Screening Statement for Strategic Environmental Assessment.
